An additional cheque for \$23.00, to cover administrative costs, made payable to the Martial Arts Industry Association Inc. is also to be included with this application

8. This application must be approved by the Martial Arts Industry Association Inc. The following attachments must be included with your application.

- Your Martial Arts teaching and training resume, this is to include:
 - i) copies of ranking certificates
 - ii) contact details of persons who have signed the certificates
 - iii) the length of time you have been studying and teaching martial arts
 - iv) details of any associations or organisations of which you are a member or with which you are affiliated
- Details of any insurance by which you or your school is covered
- A copy of any safety code under which your class may operate
- If you are making the application on behalf of a club, then please attach a copy of your current business name registration or Association/Company Incorporation certificate

Should you have previously been issued a photographic licence under either the Firearms Act, 1996 or Security Industry Act, 1997 and you have not changed your name or address since issue, you will be exempt from this requirement.
